Each type has varying degrees of complexity. Import and Warning/Fatal errors must be resolved before a school district can move their data to the next level of the Data Warehouse. Information/Warning errors allow the data to move, however, the data should be reviewed for necessary corrections prior to finalizing the submission to SIRS

Student is reported as an ESA student not School Age nor Preschool Age. The data in State Reporting Section must be manually entered indicating if child is enrolled in a Regular Early Childhood Setting or not. Applies to student who does not turn 5 years old until after BEDS Day or the Kindergarten Aged student who does not enroll in Kindergarten until Mandatory School Age of 6 years old. (Parents withholding from K)	Fatal	FRONTLINE
SS4023: W/F - Missing or Invalid Primary Setting Code in BEDS Day Snapshot.	Missing Primary Setting in State Reporting Section	Fatal	FRONTLINE

SS4035: W/F - A school age disability program record (0352-0495), for students that are 5-21 years old on BEDS Day with a K-14 or "GD" Grade Level, require a school age Primary Setting Code in the BEDS Day Snapshot	Missing Primary Setting Code in State Reporting Section.	Fatal	FRONTLINE
PS3107: Missing or Invalid demographic record	Student has probably moved and one or more Documents with the same start date have not been exited correctly. No draft is needed if the student exited before receiving services for the year.	Information/W arning	FRONTLINE
EV5040: W/F - Number of days must be greater than zero, since Event Outcome equals "Y", this chain has no link 04 (EI04) and 2024-08-31 is past 3rd birthday.	Student is missing the Process Tracking Entry of: Started Education Services	Fatal	FRONTLINE
