

B. Least Restrictive Environment (LRE) Setting is defaulted based on the following rules:

C. SIRS CSE Primary Placement Type

The Primary Placement defaults to the CSE Primary Placement Type value of the Recommended School entry selected for the student. This field is editable, and defaults to the value saved in CSE Primary Placement Type field of the Recommended School entry in Maintenance (Article 81 or Article 89 placement, or, if not applicable, "N/A"). When the default value for Primary Placement is used, "*Automatically calculated" displays next to the field. If the user manually selects a different option from the Primary Placement drop down list, the message "*Manually edited by user" displays next to the field when the user clicks Save.

The user may click on the LRE calculator icon to default the Primary Placement field back to the value in the Recommended School entry. Please note, however that the LRE field will be automatically recalculated by the system as well (this means that a manual entry of LRE will be overwritten – user will have to reselect the desired value).

D. SIRS CPSE Primary Services Program

This field displays the various service program choices defined by the State (SEIT Only, Related Services Only, etc.).

E. SIRS CPSE Primary Service Provider

This field displays the list of State approved providers for services. The provider selected should indicate the primary provider for services. The provider name may be listed under a county name other than the county that the district is located within.

F. Primary Service Provider SED Code

This field displays the associated SED code of the selected Primary Service Provider. It is derived and may not be edited.

Processing the October Snapshot Extract Data Validation Reports

Scroll down to the section labeled "Student Information Repository System (SIRS) Extracts".

Locate the October Snapshot Extract link.

Select the School Year of the Extract data file.

Click the Preview or Download button

October Snapshot Extract - Preview

- Displays the field layout on the right hand side of the screen.
- Lists each student record included in the extract.
- Students with missing required data elements are highlighted with the text "{Data Missing}" (in pink).

Preview Mode - Sample Data

F1: District Code

Identifies the district

F2: Location Code

Derived from the Recommended School information in Maintenance, based on Recommended School entered in the document. If not entered, defaults to "0000"

F3: School Year Indicator

Identifies the school year of the snapshot data.

F5: Student General Ed ID

Derived from the student's master demographic information

F31: Primary Service Code (CPSE Only)

Identifies the primary service provided to the child

F32: Primary Placement Code (CSE Only)

Identifies when the student is an Article 81 or Article 89 Placement

F35: Snapshot Date

Identifies the date of the snapshot data

F44: Primary Setting (LRE) Code

Identifies the "least restrictive environment" percentage range that the student falls within

F46: Primary Service Provider Code (CPSE Only)

Identifies the approved primary service provider

F47: School Age Indicator

Identifies whether or not the student is school-aged (if CPSE, then "N" is displayed, if CSE, then "Y" is displayed)

October Snapshot Extract - Download

Warning message displays when required data is missing, referring user to the October Snapshot Exception Report to identify those students with incomplete data.

File Download pop-up window displays when the Download button is selected, even when there are missing data elements¹.

Click "Open" to generate and view the extract file on screen.

Be sure to save the file as a CSV file format if this option is selected. Saving the download file as an Excel file will result in date formats being changed, which will cause errors when submitted to Level 0.

Click "Save" to generate and save the extract file.

Click "Cancel" to exit this window and return to the October Snapshot Extract screen.

¹NOTE: Users will still be able to generate the download file with missing data. The warning message is intended to make the user aware of potential Level 0 fatal errors, and to direct them to the October Snapshot Exception reports.
