# Monroe 2-Orleans BOCES 2021-2022 School Opening Plan

Monroe 2–Orleans BOCES is excited to have our students back beginning September 8 for in-person instruction, 5 days per week! Our 2021-2022 school opening plan incorporates updated recommendations and guidance from the Centers for Disease Control and Prevention (CDC), the New York State Department of Health (NYSDOH) and the New York State Education Department (SED) Health and Safety Guide for the 2021-2022 School Year. We will continue to monitor community transmission rates and the latest guidance and update our plan when necessary.

The following protocols are in place to ensure the health and safety of our students, families and staff:

#### Masking

Universal indoor
masking, including school
transportation is required
for all individuals including visitors in all
BOCES-owned or leased buildings and
classrooms, regardless of vaccination
status. Masks can be removed only
when eating or drinking provided
individuals are physically distanced
6 feet apart. Masking is not required
outdoors on BOCES-owned or leased
property.

## **Physical Distancing**

Individuals should maintain at least 3 feet of physical distance between one another to reduce the risk of transmission. There should be at least 6 feet of physical distance while eating or drinking when masks are not being worn.

## **Health Screening**

Performing a daily screening each morning before school/work is required. All students and staff will complete a one-time electronic attestation affirming that they will complete the screening each day. Effective September 7, there is no longer a requirement to complete the daily electronic health screening attestation. Students and staff should stay home when ill.

#### **Return to School**

Anyone who experiences symptoms of COVID-19 should stay home or go home regardless of vaccination status and contact their health care provider. Symptomatic individuals cannot return to school without proof of a negative test, alternative diagnosis or release orders from their local health department. The Monroe County Department of Health has provided protocols to address COVID-19 instances including symptomatic individuals, close contacts, and quarantine. # **Cleaning and Disinfecting**

BOCES will continue to follow the rigorous protocols that include enhanced daily cleaning and disinfecting of classrooms and offices using safe, OHSA-approved products. More information on cleaning and disinfection protocols is available at this link.

# Multi-layered Prevention Strategies

BOCES will continue to layer additional prevention strategies for added safety including PPE, proper hand hygiene, respiratory etiquette, and CDC-recommended ventilation practices to reduce the risk of transmission.

# **Social Emotional Well-Being**

BOCES 2 will utilize a 3-tiered approach to supporting the social emotional needs of students that includes community resources for students and families. BOCES staff will have multiple professional development opportunities on how to talk to and support students. Trainings on stress management, self-care and resiliency will be provided for staff to enhance their ability to support each other and students.

#### **Vaccinations**

At this time there is not

a mandate requiring students or staff be vaccinated. However, COVID-19 vaccines reduce the risk of people spreading the virus that causes COVID-19. In New York State, individuals 12 years and older are eligible to receive the COVID-19 vaccine. BOCES 2 highly encourages eligible people to get vaccinated. COVID-19 vaccines are effective at protecting you from COVID-19.
